Petition for a Conditional Use Permit – to add an Event Center + Bar & Grill at 8745 Jennings Station Rd (The Gavel) in the C-2 zoning district under NAICS code 722410.

Petitioner: CT Executive Group Dba The Gavel

Taylor: "How large is The Gavel?" Mr. Francis: "10,000 square feet." Taylor: "What about parking?"

Mr. Francis: He speaks about the possibility of an arrangement to be made with the city to accommodate parking.

<u>Jamerson</u>: "What would be your hours?"

Mr. Francis: Monday to Thursday- 4:00pm to 11:00pm, Friday and Saturday- 4:00pm to 1:00am, Sunday-closed.

Rose Eichelberger: What is the maximum capacity?

Mr. Francis: "We" do not have an exact number: Tables and Chairs- 56, Bar Chairs- 120, Bar standing room- 168. "The event center, facing Jennings Station Rd": Tables and Chairs- 59, Chairs- 127, standing room- 178. Yonnee Fortson: "Do you have members?"

Mr. Francis: There are members that pay dues. They're Freemasons.

Yonne: "You guys have been open for 3 years and you're just now getting the permit?"

Mr. Francis: "We just now applied for this process April 2nd of this year. We got a permit (Miscellaneous License) from The City of Jennings in June of last year (2022). So, this is a renewal process. Now we're now wanting to have a Liquor License."

Councilman Jeannie Roberts makes a motion to move the petition onto City Council*

*"Provided that we bring the Final County Health, because I see there are things they require for [passing], as well as a pass [from] the Fire Dept."
